

ACTIVE SAVINGS 2026 CASHBACK OFFER – WHAT YOU NEED TO KNOW

(effective from 01 August 2026)

1. Subject to the terms and conditions of this Offer if you:
- a. open a new HL Active Savings Account after the 1st August 2026 and before this Offer is withdrawn;
 - b. register for this Offer using the online registration form, Secure Message or telephone, either before opening the HL Active Savings Account or within 60 days of opening the HL Active Savings Account;

4. We will credit the cashback payment by no later than 6 months after you have opened your new HL Active Savings Account. The exact date we credit the cashback payment within this 6-month period will be determined by us.
5. Deposits can be made via debit card or Pay By Bank. It is not possible to combine the value of deposits into other HL products or accounts with different client numbers for the purpose of this Offer and internal transfers from other HL accounts do not qualify.
6. If you close your HL Active Savings Account within 6 months of opening the account or leave the balance of the account below £0.01 on the date 6 months after the account opening, the cashback will not be paid.
